

The Annual Meeting of Parishioners and Annual Parochial Church Meeting presents us with a great opportunity to take a step back from the business of parish life, and really celebrate some of the wonderful things that have taken place under the auspices of the PCC during the year. Through the pages of this report, whose foreword I am proud to write, you will be able to see how our PCC has sought to move us forward in our mission and ministry to the people of Horbury and Horbury Bridge throughout

Before May, much of the PCC's time and energy was spent handling the interregnum, saying 'good bye' to Fr Andreas and his family, and then preparing for my own arrival. I am grateful for the work that all members of the PCC put into leading the parish during that time, but particular thanks must go to the Churchwardens, Mrs Mavis Walsh and Mrs Valerie Crowther, and of course to Mr Ian Whittell, as Vice Chairman of the PCC, to whom I would like to pay particular tribute for his many years of service to us all. As the pages of this report testify, Ian continues to be missed, both for his dedication to the Lord and unremitting service to the Church. Further thanks must be paid to those who offered, and continue to offer, ordained and lay ministry in the parish, and amongst them Mrs Margaret Holmes and Mr Mervyn Ellis, as well as the wonderful (and so-called 'retired') clergy who continue in their support of us.

Returning to May, my own time here at Horbury began with a splendid service of induction, in which we were pleased to welcome the Bishop of Leeds alongside the Bishop of Wakefield, Archdeacon of Pontefract and Dean of Wakefield, who is our patron. Though I expressed my thanks to the Diocese and parish at the time, I would like to repeat these here so that they remain on our permanent record. It is a daunting prospect to begin a new ministry, let alone come to a parish as busy as this one, straight from curacy and at the youthful age of 29. (I celebrated my 30<sup>th</sup> birthday during the year and now feel very old!) But you have all been so kind in welcoming me with open arms, and I have felt your support ever since.

Inevitably, a new priest brings with him fresh ideas and new ways of doing things, but ministry should never be conducted alone, and one of the important steps our PCC has taken this year is to re-focus its work on strategy and policy, as befits what is effectively a board of trustees. Our away day in October enabled us to consider prayerfully where we have been, and which areas of our parish life we feel we need to develop, and I'm delighted that our vision to see more people coming to know Jesus Christ is one that is shared between priest, PCC and wider congregation. To this end, we have established new committees and focus groups, drawing in enthusiasm from non-PCC members as well as those who currently take a leadership role in the church, to advance our work in the areas of Evangelism, Discipleship, ministry to Children and Youth, and Fabric and Finances. These committees have already begun to meet, and make an impact on our parish life.

One of the major ways in which the PCC exercised its strategic decision-making capacity in 2017 was in the appointment of Mr Stephen Parker as our new Organist and Director of Music. It was a real coup to attract Stephen's application, and since his appointment in December, he has brought with him an indefatigable energy and buzz, transforming our worshipping life by his excellent musicianship and





directorship of the choir. The PCC, and Standing Committee in particular, should be commended for running a successful application process, whose fruits we have all benefited from, and for the preparatory work of putting a significant number of policies and other financial and legal matters in place ready to receive Stephen on Advent Sunday. They should also be thanked for investing in both Stephen's post and in remedying the problems of the pipe organ at St Peter's. As anticipated, the organ will need more money spending on it in future years – one should tend an instrument and keep it in good repair like one does a building – but the good news is that the frankly daunting project that had been envisaged has been found not to be needed.

A project that has begun, however, and which is needed, is the project to recast our peal of eight bells. In her dual role as Tower Captain and Churchwarden, Mavis has been instrumental (pun intended) in seeing this project reach the stage of faculty application. We are also grateful for the immense enthusiasm for the project amongst our band of ringers, without whom we would neither enjoy the sound of the bells, nor be able to have the problems those bells display rectified.

Added to these larger accomplishments, we must not fail to pay tribute to all the other activities which go on in the life of the parish, at both of our churches. Importantly, in the context of the annual report, I am pleased to say that, whilst we continue to struggle financially, our finances have been well managed, and this year we have managed to pay a larger percentage of our parish share than in 2016. This is an important outlay, and must be taken seriously, as it goes to providing the stipendiary ministry you receive here. Thanks for the careful management of our resources must of course go to Mick and Mary Wood, as well as to all those who continue to support the parish financially.

The activities that the pages of this this report bring to your attention are manifold, each helping to fulfil our mission as a parish. Both of our churches have successful toddler groups and Over 50s groups. At St Peter's we have Peterites; at St John's much work goes into supporting those in need through the Food Bank, as well as the purchasing of cards. Both churches have hosted catechetical groups - this year with courses on the liturgy ('Uncovering the Mystery', in the summer), evangelism ('Word becomes Flesh', in Advent) and the Temple as a hermeneutical theme for the reading of Scripture ('The House of the Lord', in Lent) - and parishioners at both churches continue to care for and look after their buildings, from making sure windows and roofs are repaired and drains are unblocked, to the regular cleaning that takes place: it <u>all</u> contributes to making those places fitting Temples for the worship of God. External groups also use our premises: a music group and the Churches Together Youth Project have begun to meet at St Peter's on Monday evenings, whilst a wide variety of community groups continue to use St John's throughout the week. There are also our schools, both of which have had busy years: at St Peter's we are in the process of appointing a new headteacher to replace Mr John Berry, who has served the school, and its predecessor Clifton school, for 23 years. Mr Berry will be missed by many in the local community: please pray for him and Pauline, and for the governors as they seek to find a suitable replacement. Horbury Bridge Academy has also been through a busy patch of staffing changes, as well as a day-long Ofsted inspection in February. Needless to say the school retains its good classification, and tribute must be paid to Mrs Janette Skinner and her team for battling through what was not an easy day!

My final thanks are paid to Mrs Lynda Wigelsworth, our PCC Secretary, for compiling the report you find in these pages. Our parish is a thriving hub of activity, committed, as our parish magazine reminds us each month, to worshipping God, offering hospitality to all, learning to be better disciples, reaching out to the local community, and acting as good stewards of the resources we have. I commend the below report for our activities in 2017 to you, and I look forward to working with you throughout 2018 as we continue to make our vision a reality here in this place.

The Parish of St Peter and St Leonard, Horbury, with St John, Horbury Bridge is a vibrant and living Christian community, on the edge of the city of Wakefield and part of the newly formed Anglican Diocese of Leeds. We are one church operating across two sites, and though parish life is both busy and varied, the worship of God, Father, Son and Holy Spirit, lies at its core. Since the days of Canon John Sharp (Vicar, 1834-99), Horbury has had a long and impressive history within the Catholic tradition of the Church of England, and displays all its hallmarks. The parish is led by Fr Christopher Johnson, who was appointed as Vicar in May 2017. Fr Christopher is supported by two Churchwardens, Mrs Mavis Walsh and Mrs Valerie Crowther, and a Reader, Mrs Margaret Holmes, who holds the Bishop's licence.

#### **AIMS AND PURPOSES**

The Parochial Church Council (PCC) of the Parish of St Peter and St Leonard, Horbury, with St John, Horbury Bridge, has the responsibility of cooperating with the incumbent, Fr Christopher Johnson, in promoting in the ecclesiastical parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical. The PCC is also specifically responsible for the maintenance of the two churches of St Peter and St Leonard, Horbury, and St John, Horbury Bridge.

#### **OBJECTIVES AND ACTIVITIES**

The PCC is committed to enabling as many people as possible to worship in our churches and to become part of our community. Our vision is:

- to see those in our pastoral cure come to worship God, Father, Son and Holy Spirit, through regular attendance at mass and other public worship, and through daily personal prayer;
- to nurture a strong, welcoming and inclusive Christian community, whose values are underpinned by the teaching of our Lord Jesus Christ;
- for all members of our church to grow in their Christian discipleship through regular Bible Study, with preaching and teaching;
- to reach out to the local community, by recognising and pledging our individual skills and talents for the benefit of all; and
- to act as sensitive stewards of the resources we have, so that God's work can continue to develop and meet the changing needs of our parishioners.

When planning our programme of activities for the year, the Vicar and PCC have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance to charities for the advancement of religion by:

- offering people the opportunity to gather together for and participate in public worship, prayer and teaching at our range of Sunday and midweek services and events;
- providing pastoral care through baptism, wedding and funeral ministry as well as the visitation of the sick;
- providing a 'gathering place' for those in particular need or with particular circumstances, through our coffee mornings and social activities, two toddler groups and fellowship groups, and by giving practical help to people in need;
- offering teaching to children and young people and providing opportunity for them to explore matters of faith;
- supporting our two church schools and local convent through regular pastoral contact;
- · delivering catechetical programmes; and

 promoting and supporting mission partnerships with other churches, as well as other local organisations.

To facilitate this work it is important that we maintain the fabric of our two churches. Our achievements for 2017 are detailed above in the opening letter from the Vicar, and below, in this collection of reports.

# STRUCTURE, GOVERNANCE AND MANAGEMENT

The structure, governance and management of the parish is determined by the rules of the Church of England, in particular the Church Representation Rules 2017. This sets out the membership of the PCC, which consists of the incumbent (Vicar), other clergy licensed to the parish, and the reader (all *ex-officio*),

together with the two churchwardens (elected at the Annual Meeting of Parishioners) and members of the laity elected to serve on the Deanery Synod or Parochial Church Council (both of which are elected by the Annual Parochial Church Meeting).

Governance of the parish is provided by the Vicar, Churchwardens and PCC, whilst day-to-day management is the responsibility of the Vicar, Churchwardens and Officers of the Parochial Church Council. Whether *ex-officio* or elected, together, all PCC members are responsible for making decisions on all matters of general concern and importance to the parish, including deciding on how the funds of the PCC are to be spent. New members receive initial training into the workings of the PCC.

The existence of the Standing Committee is required under the Church Representation Rules. It meets prior to PCC meetings to set the agenda for the meeting and transact delegated business. The PCC has also continued to delegate its social and fundraising work to the Social and Fundraising Committee. Following an away day in October 2017, during which members considered the overall strategy of the PCC, the PCC added to these two committees a Fabric and Finances Committee (yet to have its inaugural meeting) and three Focus Groups, whose membership is drawn from a mixture of PCC members and others. These three groups are tasked with developing areas of mission and ministry as requested by the PCC. The three Focus Groups currently operating are: Discipleship; Children and Youth; and Evangelism. More information about the work of the PCC during the course of the year can be found in the Report on the Proceedings of the Parochial Church Council, found below.

#### STATUTORY REPORTS

#### Report on Changes in the Electoral Roll since the last APCM

Throughout the year we have maintained our register of names on the Electoral Roll, though sadly this year we have lost seven parishioners through bereavement: June Blackburn; Joan Hazell; Christine Holbrook; Hilda Lane; Teresa Peace; John Walsh; and Ian Whittell. Five other parishioners have moved away and no longer attend church: Jennifer Coldwell; Valerie Froggett; Mark Patterson; Shirley Priest; and Karen Speight. This has meant a reduction in the Electoral Roll of twelve people. However, the church has seen an influx of new parishioners who are settling in nicely. This year we are adding eight new names to the roll: John Armitage; Pat Armitage; Ockert Blignaut; Dani Haigh; John Holland; Megan Jones; Kevin McGetrick; Stephen Parker; Karen Scharnhorst; and Helen White. The total number on the roll therefore stands at 145, of whom 98 live within the parish and 47 live outside. 118 members of the roll primarily worship at St Peter's and 27 worship at St John's.

#### Report on the Proceedings of the Parochial Church Council

It has been another busy year since the last APCM. Our previous year involved keeping the ship 'steady' and searching for a new priest. Thankfully, early in 2017 we looked forward eagerly to welcoming Fr Christopher. Fr Christopher hit the ground running: since his arrival the entire PCC has been enthused and energised by the progress made during the six full PCC meetings held, along with five Standing Committee meetings and the 'away day'. Much work has been initiated in focus groups and new systems put in place, which will help us all to move forward positively in all we hope to achieve. Given its desire for growth, the PCC has formed a number of new groups, each dealing with a particular aspect of parish life that we feel needs addressing at this time. These groups, which include Evangelism, Discipleship, Children and Youth, and Fabric and Finance, together with the long standing Social and Fundraising Committee, are all responsible to the PCC and report back to it regularly, with minutes of their decisions

being received by the full PCC and discussed as necessary. We now look forward to another year of fellowship, fun, outreach and growth in the parish.

#### Financial Statements of the Parochial Church Council

This report is on the 2017 financial year for the Parish of St Peter's and St Leonard's, Horbury with St John's, Horbury Bridge and is based on the audit figures as presented to the PCC.

The overall unrestricted income for the parish was £74,396.98, which is marginally down on 2016 income (£577.65). However, our basic weekly giving income was £31,765, down nearly 8.5% on last year. It's only the HMRC Gift Aid refund and collections at other services that has raised this portion of the income above the 2016 figure. The HMRC amount for 2017 was boosted by a late 2016 payment of £7,007. Sadly Ian Whittell's illness and passing has delayed the final 2017 refund but I'm sure Michael Turner will have the matter well in hand and we will benefit from receipt of the monies in due course.

Donations from Church Groups and individuals was up 21% on 2016 at £3,584 and our Events and Fund Raising once again provided over £17,000. A big thank you to all involved in attending and organising these activities.

The Diocesan Quota in 2017 was £58,007 of which we managed to pay £42,000 (£4,500 more than last year). The Quota for 2018 has been reduced by the Diocese to £55,671, still a very large sum to pay out of an unrestricted income around the £75,000 mark but we will strive to attain the payment.

Church Running Expenses are down a little but insurance is still a large sum at £8,500 per annum. Please note the current offer from Ecclesiastical Insurance of a donation to the Parish of £180 for each private policy taken out by a church member – details on the church notice boards and the March magazine.

Maintenance and Repairs were within expectations and as usual thank you to all the willing workers keeping our costs down with general maintenance jobs.

Salaries and Honorariums were also higher than 2016 but should now stabilize with the appointment of our organist, Stephen Parker.

The window repairs and roof work at St John's are finally completed and they comprised the Fabric Fund outgoings. Repairs to the Lady Chapel roof at St Peter's will take place in 2018 but there are sufficient funds available in the Fabric Fund to cover the expense.

2018 also sees two fund raising projects start in earnest, firstly for the re-casting and re-hanging of St Peter's bells, which are becoming increasingly difficult to peal – good luck and fortune to the team involved! Secondly, following the overhaul, repairs and re-tuning of St Peter's Harrison organ, there will be an ongoing maintenance and tuning programme to ensure it maintains it's wonderful sound and doesn't fall into disrepair – again happy fund raising to all involved in this project.

Finally, my usual thanks to everyone for their generous planned giving in 2017, this regular income does ensure our ability to cover the costs of our Mission and Parish overheads. However, I appreciate that times are hard monetarily, but could you afford to give a little bit more? When did you last upgrade your giving? Another 10% would be really helpful and giving by Standing Order or Direct Debit would be even

more help. Please give the matter your serious consideration. See Michael Turner or myself for the necessary forms and details of how you could help to maximise our Gift Aid claims.

#### Report on the Fabric, Goods and Ornaments of the Churches of the Parish

#### At St Peter's:

- the Parish Room gutters and roof lights have been cleaned;
- the north transept window alcove has been painted;
- two loose flags in the Sanctuary have been refitted;
- a loose wall panel in the Sanctuary area has been refitted and repainted;
- the Lady Chapel roof has had repair work carried out;
- the low level asbestos on the inside of the meter cupboard has been painted with asbestos sealing paint; and
- the Harrison and Harrison Organ has had repair work carried out and has been tuned.

#### Report on the Proceedings of the Deanery Synod

The Deanery Synod has met four times in the course of the annual meeting year, plus a postponed meeting, rescheduled due to the recent snow, for the end of April 2018. Our Deanery Synod Representatives plus Fr Christopher attended three out of the four meetings. The meetings covered: dementia, and how the church can help support those suffering from that condition, for instance by considering the building and its layout and promoting dementia awareness; the environment, and whether we were taking our duties of looking after God's creation seriously, and what we can do to improve that; and how we see God in our workplace. Each had a keynote speaker. The postponed meeting will receive a talk by Canon Andrew Norman, Director of Ministry and Mission, and Ms Karin Shaw.

#### NON-STATUTORY REPORTS

#### Music

Since taking up the post of Organist and Director of Music on Sunday 3<sup>rd</sup> December 2017 I have been extremely welcomed by both St Peter's and St John's congregations, and I am thoroughly embracing the richness of the services and liturgy. There has been a lot to sort out but much has already been achieved in a short space of time.

Choir practices have been reinstated and are now taking place on Tuesday evenings from 6-7pm at St Peters Church. There was a invitation for singers to join for the carol service and this was well received and three new members remain in the choir as a result of this. This takes the total choir membership to II. Sadly we lost one of our long-standing members at Christmas – Ian Whittell. The choir sang beautifully at Ian's Requiem Mass. We thank God for all that Ian contributed to the life of the church.

It was decided to reposition the choir from the first two rows of pews for various reasons, with the main one being that the singers constantly had to turn round and face the congregation during the sung parts of the mass (which was felt to be unsatisfactory). They moved into the chancel and were positioned in one long line, but this did not work due to lack of space (and the fact that they were unable to hear each other). They are now positioned in the sanctuary in two rows, enabling them to sing out towards the congregation. The choir are happy with this position. There was a proposal to purchase new music stands (in keeping with the church's furniture) but choir members did not feel the need to go ahead with the purchase and are happy to continue holding their music. At Christmas the choir were asked to wear black and white to provide some kind of identity/uniform. New blue scarves were purchased for the ladies (by the choir members themselves) and the possibility of more ecclesiastical dress may be introduced in the future, given that the choir are now much more visible in the sanctuary.

Choir bulletins have been produced to aid with communication (especially for Christmas and Easter services). A choir diary has also been introduced to help plan for holidays and absence. New black folders have also been purchased for each choir member, as have box files to store music for all the festivals etc. (all at no cost to the church). The choir has responded well to all the new music they have learnt, especially during the carol service and Candlemass and at the time of writing, we are currently working very hard towards Easter and Holy Week.

The organ at St Peter's needed attention before my appointment. The PCC very kindly agreed for two full days work to be spent on the organ (this actually resulted in three full days, but at no additional cost to the church). This work was carried out by J M Spink Organ Builders of Leeds, and they have done a tremendous job at sorting out many long-standing faults. Everything is now working and J M Spink have since taken over maintenance and tuning (which will be carried out twice a year). It is hoped that further phased restoration will take place in the future (i.e. dealing with the many perishing leather motors). The organ was built in 1921 and is coming up to its centenary celebration – watch this space! Various organists have been to St Peter's and played the organ since the work has been completed and they have commented how much better the organ is now sounding.

Dr Simon Lindley (Leeds City Organist) came to look at the organ in January, as he is one of the Trustees of the Pilling Trust, which awards churches grants towards restoration projects. This was an informal but very informative meeting. After playing and hearing the organ, Simon said 'This is magnificent and needs preserving/restoring at all costs'. Hopefully we will pursue grants and funding in the near future.

The organ loft has now been cleared of all unnecessary items and thoroughly cleaned, making it a functioning working space rather than a place for storage. The floor has been stained and varnished and now looks loved and cared for. Various cupboards and shelves have been re-located and utilised to store organ and choir music.

The organ at St John's is in very good condition, having been extensively restored and reduced several years ago at the bequest of Arthur Bowers (former long-standing organist). This work was carried out by Wood of Huddersfield – Organ Builders. There have been just a few minor issues to sort out and this work is currently ongoing.

The Clavinova is well used for choir practices and concerts and a new matching stool has been purchased at no cost to the church.

The Wyvern Computer Organ is no longer used for regular worship and has been moved from its original position. The PCC has since decided to dispose of his instrument – it is 26 years old and the technology is somewhat dated. The additional speakers were purchased by the former organist, Diana, who has kindly given permission for these to be sold with the organ.

There was little in the way of music/resources when I arrived at St Peter's and most of the music the choir are now using is from my own collection. We hope to build this up in time. There have been some slight changes to the mass setting in recent week – the Sursum Corda, Memorial Acclamation and chants for the Amens – so that priest and people are all working from the missal, as adopted by the PCC.

To assist with my understanding and knowledge of plainsong I have attended a half-day course at Leeds Roman Catholic Cathedral. The experience was informative and has increased my understanding.

There is always more to do and new music to learn, but together we are gradually building things up and it would be nice to have more choir members (especially men). I want to say a big thank you to the choir for their commitment and willingness to embrace the changes I have introduced as Director of Music. I also want to say a big thank you to Fr Christopher for his time, support and encouragement. We meet once a month to look at future music requirements – this is invaluable as we share in the responsibility of choosing music. My thanks also go to Barbara Panton and John Cuttell who provide cover when I am unavailable or on holiday.

Please pray for me and the choir and encourage us as we continue to offer our gifts in worship.

#### **Evangelism Focus Group**

At the away day in October, the PCC expressed its desire to focus efforts on several key areas in our parish life, including evangelism – that is, encouraging new people to come to know Jesus Christ and worship God. Since 2018, the PCC has delegated development in this area to an Evangelism Focus Group, which has now met twice. The group's initial work consists of trying to improve our image within the local community. As such, new publicity and literature has been created for our Christmas and Easter services – thanks go to all those members of the congregation who took the leaflets out into the parish! Our Christmas leaflet drop, together with an emphasis on evangelism through our Advent course, led to an increase in attendance at church of 20% over the season, with the carol service in particular being up 80%. Let's try to make the same happen at Easter! The group is also looking at new signage for St Peter's, inside and out, and the creation of an updated website. Welcome literature is also to be created for both churches, and the service sheets and pew sheets made more accessible to new worshippers. The PCC is currently applying rules ahead of changes in Data Protection law, and the group is using this necessary development to create a new mailing list, to help spread details of our services and events. Furthermore, we now have a solid presence on social media, Facebook and Twitter, with 93 and 125 followers respectively – that's over 200 people already who now see what we're up to. Do 'like' or 'follow' us on those platforms, or invite your friends to do so, to see up to date information about what has happened in the parish (lots of pictures celebrating all the good things which go on!), together with news about services and events that are going to happen in the near future. Thanks go especially to the Bishops' Development Fund of the Diocese of Leeds for a grant of £1000 to complete some of this vital work in spreading the word and building up our numbers.

#### Children and Youth

Children and young people continue to form part of our parish, attending both our worship and the activities we run during the course of the week. Developments with safeguarding processes and procedures, for instance, mean that we now have an Organist in place, who, together with the Head Server, is fully DBS checked, which will enable us to welcome children into the choir and to the serving team – and if you know of anyone who may be interested, please put them in touch with Fr Christopher! New resources have also been purchased for the children's corner at the back of St Peter's, which many children enjoy during mass or when visiting for baptisms, and resources are currently being put together to enable children to engage in the mass itself, given the decision to cease operation of the Sunday School.

Children and youth work is an area the PCC has identified for development, and since the beginning of 2018, we have formed the Children and Youth Focus Group. At our first meeting, members planned a series of family activities throughout the course of the year. These include a Good Friday workshop ('Tomb Raiders'), summer holiday club, 'Dingle Dangle Scarecrow Day' harvest workshop, and Christingle service. Please promote these events to anyone who is eligible to come. Carol Tattersfield and Carol Holdsworth have also taken three young people away on the Walsingham Children's Pilgrimage, and returned safely!

Fr Christopher joins Margaret Taylor and Margaret Lister as a foundation governor at St Peter's School, and is sitting on the committee seeking to appoint a new headteacher to replace Mr Berry. He and Margaret Holmes alternate delivering collective worship at the school on Thursday mornings. Fr Christopher also joins Valerie Crowther as a foundation governor at Horbury Bridge Academy, which has recently undergone a one-day inspection by Ofsted. Fr Christopher visits the school every Thursday to see EYFS and to lead collective worship for the whole school. Both schools use their respective churches regularly.

ABC and JAMS are our toddler groups, for parents, grandparents, and their babies and children up to school age. ABC meets every Tuesday morning, and JAMS every Wednesday morning, in term time. #### **Horbury Churches Together**

In common with many groups and societies, Horbury Churches Together has seen a number of departures and arrivals in the last 12 months. We thank those who have departed, many to pastures new, for their hard work in preceding years and welcome those who have joined our small but committed group.

In line with Charity Commission requirements the Trustees have continued to ensure that our activities have the widest possible public benefit, that assets and resources are used to further the Objects of the Constitution. Our funds have been ethically sourced and control of finances has been maintained, while legal rules have been complied with and relevant policies adopted and updated as necessary. There continues to be open access for all our events and activities and this is in line with Equal Opportunities and our underlying Christian principles.

The United Service in January 2017, led by Fr Andreas was well received by our various congregations, as was the Forum held at Horbury Methodist Church, with a speaker from Christian Aid, who told us a little of what the organisation does.

In February 2017, there was an open access Reflection Day at St Andrew's, Netherton and though only a very small group were able to come, the opportunity to discuss and reflect on 'Prayer' was greatly appreciated.

The Good Friday service was held at St Mary's, with contributions from all the other churches, and on Easter Saturday our distribution of Easter Eggs and HCT leaflets at the Co-Op gave us the opportunity to reach out to the community. A very important aspect of our 'work'.

Over £3,000 was raised by HCT during Christian Aid week and we thank all the churches for their contributions. They do seem to come up with a variety of ways to raise the money each year.

In early June we held our free Whit Community Party at Horbury Academy, this included garden games, a bouncy castle and barbeque and much more. It was a huge success with an estimated attendance of over 200. We hope to keep building on this success, so please look out for this years' party on 26<sup>th</sup> May.

The Horbury Breakthru Youth Project has had a busy and successful year including the Annual Awards evening in July. The work they do continues to offer a wide variety of activities for the children to be involved in, and gives them the opportunity to develop skills which many would not otherwise be able to do. The children continue to participate in the organisation of activities through the Youth Management Committee and the Youth Advisors to the Trustees have attended the quarterly Trustees Meetings. They are always keen to get involved and bring a different but welcome perspective to the meetings. They particularly worked very hard with the Trustees to research and prepare our successful Big Lottery Fund bid.

The annual Youth Lunch took place in December with inclusive entertainment from the young people. It was good to see people from across the different generations of our community come together to share food and social time together.

The joyful end to our calendar of events took place near Christmas when we again joined together at the Co-Op for carol singing and distribution of chocolates for the children. This was our final community reach out for the year as we also distributed information about services across the community over the festive period.

We welcomed Fr Christopher to the HCT Trustees in August and would warmly welcome anyone else from St Peter's or St John's who feel they have some time to give to this very worthwhile aspect of our Christian Witness in Horbury – the more people we have the less work there is to do!
